2. The partnership is to establish friendly connection and foster communication and exchange between the two institutions. This partnership will constitute both the form of content and ideas sharing across the Internet and in-person interaction.
  - a) Both institutions will send out invitations to the other for guest lectures and conferences. The host institution will provide guidance for the visiting institution. The institutions will be able to establish in-person connection, which will help to strengthen the relationship of two institutions.
  - b) Meghnad Desai Academy of Economics will offer its premises for Bhawanipur Education Society College to host events in Mumbai as and when available.
  - c) Bhawanipur Education Society College will offer its premises for Meghnad Desai Academy of Economics to host events in Kolkata as and when available.

  - e) The professors from Meghnad Desai Academy of Education will conduct guest lectures for the students of Bhawanipur Education Society College.

4. This MOU shall be valid till 31/03/2020 and may be extended with mutual consent. The MOU may also be terminated by giving one months' notice to other party.
