PREAMBLE

The Bhawanipur Education Society College, (BES) Kolkata, West Bengal, India and Lady Brabourne College Kolkata, West Bengal, India, after their communications and a number of collaborations have agreed to sign a formal Memorandum of Understanding (MOU). The Department of Bengali of The Bhawanipur Education Society College and The PG Department of Bengali of Lady Brabourne College desire to establish certain cooperative programs among the departments of Bengali of both the institutions. This will be beneficial to both the educational institutions. The general purpose of this MOU is for organization of joint publications, seminars and webinars, conferences, workshops, certificate programmes and extension activities.

MEMORANDUM OF UNDERSTANDING (MOU)

In contemplation of the relationship to be established and for consideration Parties agree as follows:

- 1. This MOU replaces any and all previous agreements between the Parties. Subsequent discussions, agreements and understandings whether verbal or in writing are subsumed by this agreement. Any changes required will be in the form of written agreement between both the institutions.
- This MOU is not considered to be a contract creating legal and financial obligations between The BES College and Lady Brabourne College. This agreement is designed to facilitate and develop genuine and mutually beneficial study programs, research relationships and extension programs.
- It is agreed that the Department of Bengali, The BES College and the Department of Bengali, Lady Brabourne College will work together to promote the following:
 - A. Publications by Faculty and students
 - B. Seminars, Webinars, Conferences and Workshops
 - C. Certificate Programmes
 - D. Extension Activities
- 4. This MOU shall not be construed to create a relationship of partners, brokers, employees, servants, joint ventures or agents as between the Parties. The Parties to this MOU are acting as independent participants. In the event that the Parties decide to engage in activities which involve employment, separate agreements addressing those issues will be required.

DURATION AND TERMINATION

- 1. This MOU shall enter into force on the date of signing the agreement and shall remain in force for a period of Five (5) years and may be extended for another period of Five(5) years by the mutual written consent of the Parties.
- 2. Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this agreement at least 6 months prior to the date of termination.
- 3. The termination of this MOU, however, shall not affect the completion of any project/s and programme/

AMENDMENT

- 1. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this agreement.
- 2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

SETTLEMENT OF DISPUTES

1. Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between the Parties.
